The Davis-Bacon Act requires contractors and subcontractors working on federally funded jobs to pay their laborers wages and benefits no less

# Get Free Davis Bacon Act

than what others locally pay their workers for similar projects. This is called the “prevailing” wage. Under Davis-Bacon, contractors can pay this wage out as a combination of cash and fringe
